ADOPTION OF CONSENT AGENDA: Skiera moved, Tighe seconded to approve the Consent Agenda: Board Meeting Minutes of September 10, 2024, Expense Voucher of September & October 2024, Treasurers Report of September 2024 and adoption of the agenda. REPORTS:

- 1. Fire Department: Reported a 4.21% increase in runs, tires are being replaced on three trucks, and MFR candidate training was taking place at the Fire Station tonight.
- 2. Ambulance: Reported attendance at the Brethren Fire Prevention Day.
- 3. Assessors: Reported processing of deeds and property transfer affidavits with the 2nd round of permit inspections forthcoming.
- 4. Custodian: Reported a new projector and screen have been installed at the community center, the floor has been completed with the exception of the ¼ round that is on order, blower buggy for leaf blower has been received.
- 5. Transfer Station: Reported that crushed concrete has been installed at the transfer station in conjunction with the new entrance shed. Requested if anyone had a bar height stool or chair to donate that it would be greatly appreciated.
- 6. Management Council reported that the new floor has been well received, booking most weekends in October.
- 7. Park and Recreation reported that things are winding down.
- 8. Planning reported Master Plan work continues.
- 9. Zoning reports junk and blight issues are being addressed and cell tower negotiations continue.
